MARKING

Every roll (rolled pipe) has to be tied up and taped with a durable adhesive strip with marking. The minimum required marking is:

- the manufacturer's name and/or trademark;
- KOMO®-logo and certificate number;
- the text "PP" or "PE/PP";
- type 450 μm, 700 μm or 1000 μm;
- the length of the roll in m¹⁾;
- the production date or -code ¹⁾.
- 1) The marking can also be on a durable label.

Every wrapped, corrugated pipe has to be marked with the trademark of the used pipe. The lable with marking, beloning to the corrugated drainage pipe has to be installed again after wrapping, unless the remaining marking is forseen with the trademark of the pipe.

APPLICATION AND USE

The products are intended to be used for the wrapping of corrugated drainage pipes. Applying conditions:

- BRL 1401 " Corrugated drainage pipes made of PVC";
- BRL 1410 "Corrugated drainage pipes made of PE, PP and mixtures of PE and PP ";
- The supplier's processing guidelines.

During the transport of the pipes, any kind of damage of the wrapping has to be avoided. The pipes can be mounted with all types of common drainage machines. Any contact with sharp materials or protuberances has to be avoided.
